कोर्ट द्वारा टीचर्स एलिजबिलिटी टेस्ट अभ्यर्थियों के पक्ष में दिए गए फैसले अब टीईटी पास अभ्यर्थियों ने भी उसे नौकरी देने की मांग शुरू कर दी है। को लेकर जालौन के कलेक्ट्रेट परिसर में टीईटी पास अभ्यर्थियों ने प्रदर्शन करते हुए जिलाधिकारी के माध्यम से मुख्यमंत्री को ज्ञापन भेजकर जल्द प्रक्रिया शुरू करने की मांग की है। मांग न मानी जाने पर टीईटी अभ्यर्थियों ने आंदोलन और आत्मदाह की धमकी दी।

उल्लेखनीय है कि मायावती सरकार ने 2011 में टीईटी पास अभ्यर्थियों के लिए प्राथमिक विद्यालय के सहायक अध्यापक के लिए 72825 पद निकाले थे, लेकिन सरकार बदलते ही अखिलेश सरकार ने नया विज्ञापन जारी कर दिया था और उस विज्ञापन को

इस विज्ञापन पर सवाल खड़ा करते हुए टीईटी पास अभ्यर्थियों ने कोर्ट का दरवाजा खटखटाया था, जिसके बाद हाईकोर्ट ने अखिलेश सरकार के विज्ञापन को रद्द करते हुए टीईटी के नंबर के आधार पर भर्ती प्रक्रिया शुरू कर दी थी। जिसमें लगभग 66 हजार टीईटी अभ्यर्थियों की भर्ती पूरी हो गई थी, लेकिन मामला सुप्रीम कोर्ट पहुंचा जहां लगभग पांच साल बाद 25 जुलाई को सुप्रीम कोर्ट ने फैसला सुनाते हुए सात दिसंबर 2012 के विज्ञापन को वैध करार दिया और एकेडमिक आधार पर नियुक्ति कराए जाने के लिए कहा। इसी को लेकर शनिवार सैकड़ों टीईटी पास अभ्यर्थी उरई के कलेक्ट्रेट परिसर पहुंचे जहां उन्होंने नारेबाजी करते हुए प्रदर्शन किया। साथ ही योगी सरकार से जल्द काउंसलिंग कराकर नियुक्ति पत्र दिए जाने की मांग की।

घाघरा नदी में हो रही तेज कटान से सदर बांधों का अस्तित्व खतरे में नजर आ रहा है। तहसील के पिपरपाती और चांदपुर गांव के प जाने से नदी का पानी केशवपुर गांव की तरफ रामपुर कलचारी बांध और ठोकरों पर दबाव इंजीनियर ठोकरों की मरम्मत में जुटे हैं।

दूसरी तरफ हरैया तहसील के विक्रम जोत नदी की कटान से 500 मीटर लंबाई में बैठने से है, जबकि कल्याणपुर गांव के पास प्राइमरी स्कूल का अस्तित्व खतरे में है। साह जावरा गांव में घागरा और टेढ़ी नदियां कहर मचा रही हैं। दोनों नदियों की धारा से चारों तरफ से घिरा यह गांव पूरी तरह टापू बन गया है। कल्याणपुर गांव को बाढ़ से बचाने के लिए प्रदेश सरकार ने 37 लाख रुपए दिए हैं, पर बाढ़ डिवीजन के इंजीनियरों ने 13 लाख रुपए और खर्च कर दिए।

जाधव की याचिका पर सैन्य अदालत ही फैसला करेगी : बासित

नई दिल्ली, 29 जुलाई।

भारत में पाकिस्तान के उच्चायुक्त अब्दुल बासित ने शनिवार को कहा कि कुलभूषण जाधव की दया याचिका पर पाकिस्तान की सैन्य अदालत ही फैसला करेगी। भारतीय नौसेना के पूर्व अधिकारी जाधव को पाकिस्तान की सैन्य अदालत ने जासूसी और विध्वंसक साजिश रचने के आरोप में मौत की सजा सुनाई है। भारत सरकार ने इस फैसले के खिलाफ अंतरराष्ट्रीय न्यायालय में अपील की है। दूसरी तरफ, जाधव ने पाकिस्तानी सेना प्रमुख के पास सजा माफी की अपील की है। भारत और पाकिस्तान के रिश्तों में हाल के दिनों में आई खटास को लेकर उन्होंने उम्मीद जताई कि हालात सुधरेंगे।

बासित ने पाकिस्तान उच्चायोग में संवाददाताओं से बातचीत में कहा कि जाधव को सजा सुनाई जा चुकी है। उनकी दया याचिका पर सैन्य अदालत ही फैसला करेगी। बासित इस महीने के अखिर में सेवानिवृत्त हो रहे हैं। पाकिस्तान सरकार ने विदेश सेवा से समयपूर्व निवृत्ति की उनकी अर्जी स्वीकार कर ली है। वे अप्रैल 2018 तक रिटायर होने वाले थे, लेकिन पाकिस्तान का विदेश सचिव नहीं बनाए जाने पर उन्होंने इस्तीफा दे दिया था। भारत में बासित की जगह सुहैल महमूल लेंगे, जो अभी तुर्की में पाकिस्तान के दूत हैं।
